#### **Position**

We are looking for (2) full-time **Core Logging Geologist** for a temporarily 5-6 months contract. The role will be based at the Minto mine, which is a camp-based operation with a two-week on/two-week off rotation.

- Extended periods of time standing throughout the day;
- Must possess a valid driver's licence;
