



The Selkirk First Nation purchased the past-producing Minto Mine out of bankruptcy, and the mine will be vended into Venerable Ventures Ltd. to create Selkirk Copper Mines Inc. The Minto Mine is an idled open-pit and underground copper-gold-silver mine located in central Yukon, on lands of the Selkirk First Nation. The site infrastructure includes a 4,100 tpd processing plant, 400-person camp, water treatment facilities, numerous ancillary buildings and mobile equipment.

Selkirk Copper Mines is focused on advancing the Minto Mine through a sustainable manner in partnership with the Selkirk First Nation, and is committed to building a skilled and diverse workforce as the company advances through exploration, development, construction and into production in the near-term.

Job Title: Mine Site Controller

The Mine Site Controller is a key financial leader at the Minto Mine site, responsible for overseeing all financial functions, ensuring cost control, financial reporting and compliance. This role supports exploration, care & maintenance, development, design & engineering, the construction and operational phases, requiring a deep understanding of financial management across the mine lifecycle.

- Track and report on capital expenditures, ensuring alignment with authorized budgets.
- Oversee the day-to-day accounting of the operations, ensuring all transactions are managed in accordance with the Company's defined governance policies and procedures.
- Oversee preparation of monthly management reports to deliver timely, value-added analyses, key metrics, and reports to support departmental cost reviews.
- Drive the planning cycle for annual budgets, quarterly forecasts, and life-of-mine plans. Challenge and validate inputs and work with department heads to develop quality plans.
- Implement, maintain, and continuously improve the output from company's ERP. Involvement in defining business processes and workflows associated with the Company's selected ERP system
- Prepare cash flow forecasts for the operations and submit timely cash calls to head-office.
- Work with site operations to drive understanding of cost drivers and collaborate on cost improvements.
- Facilitate a robust internal and external financial reporting cycle and provide technical (financial reporting) guidance to the operational staff when required.
- Liaise with the mine's procurement team to ensure compliance with delegation of authority as it relates to contracts and reporting processes as well as efficient deployment of the company's working capital.
- Interact and provide direct support to senior executives and management on finance-related matters.
- Coordinate the flow of accurate, timely and meaning financial information for the Minto Mine to site and the corporate office.
- Ensure compliance to corporate accounting policies and IFRS.

- 7+ years of mining industry finance experience.

- Experience in implementation of ERP systems considered an asset.
